GUIDANCE ON SEX ESTABLISHMENT LICENCE APPLICATIONS

GRANT, RENEWAL AND TRANSFER OF LICENCES FOR SEX ESTABLISHMENTS

WHAT TO DO

1. An applicant for the grant, renewal or transfer of a licence shall give public notice of the applicant.
2. Unless otherwise agreed, applications must be received not less than 28 days prior to the business opening.
3. The Council will normally require that new applications or applications for substantive permanent changes (eg: increased hours) to be advertised in a local newspaper in an agreed form.
4. Applicants will be required to advertise for one consecutive week in local newspapers of the intention to open such an establishment.
5. The publication shall not be later than 7 days after the date of the application.
6. Where the application is in respect of premises, notice of it shall in addition be displayed for 21 days beginning with the date of the application on or near the premises and in a place where the notice can conveniently be read by the public in the prescribed form.
7. Every such notice which relates to a vehicle, vessel or stall shall specify where it is to be used as a sex establishment.
8. The Council will normally expect that the Licence holder is resident locally in the Borough of Bracknell Forest and in direct control of the licensed premises. Applications from 'remote' owners or managers will normally be expected to be made in joint names with the local resident manager.
9. An applicant for the grant, renewal or transfer of a licence shall, not later than 7 days after the date of the application, send a copy of the application to the chief officer of police.

10. In determining the application the Council will consult with the Police and take due account of their comments embodying them as conditions to the licensee if appropriate.
11. The views of the Ward Members will be sought and regard will be given to any relevant past experience relative to either the applicant or the premises.
12. Applications from unsuitable applicants, or in respect of premises that are deemed unsuitable either by virtue of their construction, lack of facilities or location will be refused. Applicants will be advised of the grounds for the refusal and there is a right of appeal.
13. In the case of a new application, a **scale 1:100 plan** of the proposed licensed premises/area showing all fire precautions **MUST** accompany this application. In the case of a Renewal, you need only enclose this if there have been, or are proposed to be, any changes since the previous application.
14. In the case of a new application, you will be required to advertise, for a period of one week in a local newspaper, your intention to apply for a licence (advice on the suitable wording for the advert is available from the Council at the address shown at the end).
