

Level 2 Anti-Social Behaviour Types
as recorded on CADIS

| Incident Type | Source | Description |
|---|---|--|
| Abandoned Vehicle - Destruction | BFC - Environmental Health | Vehicles abandoned and destroyed immediately (other than burnt out) |
| Abandoned Vehicle - Refuse Disposal Act | BFC - Environmental Health | Vehicles abandoned and disposed of under the Refuse Disposal Act |
| Arson / Fire | Thames Valley Police | Incidents of fire or arson which have not been recorded as a crime |
| Assault | Thames Valley Police | Incidents of assault which have not been recorded as a crime |
| Burnt Out Vehicle | BFC - Environmental Health | Vehicles disposed of by BFC which have been burnt out |
| Dangerous Driving | Thames Valley Police | Driving considered to be dangerous but not crimed e.g. displaying, road rage, mini motorbikes, off road driving, speeding. |
| Drug related | Bracknell Forest Homes | Incidents where drugs are thought to be used/dealt |
| FDR1 Fire | Royal Berkshire Fire and Rescue Service | A deliberate fire where property is involved e.g. owned buildings or vehicles (i.e. not derelict), crops in fields (e.g. where there is an owner and a value is attached to them). An FDR1 form is also required if there is a fire and there are fatalities, casualties, rescues or escapes, or if there are 5 or more appliances attending, or if it was a small fire that spread from one location to another. |
| Fight | Thames Valley Police | Reports of fights which have not been recorded as a crime. |
| Firearm | Thames Valley Police | Reports of firearms either seen or used which have not been recorded as a crime. |
| Fly Tipping | Thames Valley Police | Dumped rubbish or fly tipping reported to the police. |
| Graffiti/Fly Posting | BFC - Street Care | Incidents of graffiti dealt with by Street Care. Also reports of fly posting. |
| Harassment | Thames Valley Police/ Bracknell Forest Homes | Incidents of harassment which have not been recorded as a crime. For example Nottingham Knockers, being followed, refusing to leave, name calling, playing football, offensive language, objects thrown at property, etc where the activity is likely to cause harassment, alarm or distress. |
| Indecency | Thames Valley Police | Indecent acts e.g. sexual acts which have not been recorded as a crime. |
| Indecent Exposure | Thames Valley Police | Indecent exposure that has not been recorded as a crime. |
| Neighbour Dispute | Thames Valley Police | Incidents involving neighbours where contact has already been made in an attempt to resolve the situation but the problem has not been recorded as a crime e.g. noise complaints, parking issues, harassment, etc |
| Noise | Thames Valley Police | Noise complaints that have not been recorded as a crime. |
| Noise - Dogs Barking | BFC - Environmental Health | Complaints of dogs barking reported to Environmental Health. |

| Noise - Domestic | BFC - Environmental Health | Complaints of domestic noise reported to Environmental Health. |
| Rangers - Arson | BFC - Rangers | Reports from the Parks and Countryside Rangers of arson e.g. play equipment damage, litter bins, small fires in parks, etc |
| Rangers - Assault | BFC - Rangers | Reports from the Parks and Countryside Rangers of assault that have not been recorded as a crime. |
| Rangers - Broken Glass | BFC - Rangers | Reports from the Parks and Countryside Rangers of excessive broken glass e.g. broken beer bottles. |
| Rangers - Burnt Out Vehicle | BFC - Rangers | Reports from the Parks and Countryside Rangers of burnt out vehicles that have not been recorded as a crime. |
| Rangers - Dangerous Driving | BFC - Rangers | Reports from the Parks and Countryside Rangers of dangerous driving that have not been recorded as a crime e.g. mini motorbikes, displaying in parking areas. |
| Rangers - Drugs | BFC - Rangers | Reports from the Parks and Countryside Rangers of drugs paraphernalia e.g. foils, needles, bongs |
| Rangers - Dumped Rubbish/Fly Tipping | BFC - Rangers | Reports from the Parks and Countryside Rangers of dumped rubbish e.g. excessive litter, beer cans |
| Rangers - Harassment | BFC - Rangers | Reports from the Parks and Countryside Rangers of harassment to a member of staff. |
| Rangers - Indecency | BFC - Rangers | Reports from the Parks and Countryside Rangers of indecency e.g. sexual acts. |
| Rangers - Noise (All) | BFC - Rangers | Reports from the Parks and Countryside Rangers of noise. |
| Rangers - Threat | BFC - Rangers | Reports from the Parks and Countryside Rangers of threats to one of the members of staff. |
| Rangers - Vandalism | BFC - Rangers | Reports from the Parks and Countryside Rangers of vandalism other than broken glass e.g. damage to play equipment, damage to lifebuoys, etc |
| Road Hazard | Thames Valley Police | Incidents that cause a road hazard reported to the police but not crimed for example vehicles parked on footpaths forcing pedestrians/prams/wheelchairs to use the public highway, roadwork signs placed in the road, stones or other objects thrown at vehicles or placed on the public highway, persons intentionally walking on the public highway e.g. drunks. |
| Secondary Fire | Royal Berkshire Fire and Rescue Service | A small (or Secondary) fire is an uncontrolled burning involving heat, flames or smoke other than a FDR1 fire. |
| Street Care - Broken Glass | BFC - Street Care | Reports of excessive broken glass reported to Street Care. |
| Street Care - Dumped Rubbish | BFC - Street Care | Reports of dumped rubbish reported to Street Care. Normally: Less than one black bin liner (unless left by road side for Refuse Collection). |
| Street Care - Fly Tip | BFC - Street Care | Report of fly tipping reported to Street Care. Any of: More than one black bin liner (unless left by road side for Refuse Collection); Industrial waste; Non-domestic waste left road side for Refuse Collection. |
| Street Care - Hypodermic Syringes | BFC - Street Care | Reports of hypodermic needles reported to and disposed of by Street Care. |

| Threat | Thames Valley Police/ Bracknell Forest Homes | Incidents involving threats either reported to the police (but not crimed) or by Bracknell Forest Homes e.g. threat to property, threat to person |
| Town/Parish - Abandoned Vehicle - Dangerous | Town and Parish Councils | Reports of dangerous vehicles reported by town or parish councils. |
| Town/Parish - Broken Glass | Town and Parish Councils | Reports of excessive broken glass reported by town or parish councils. |
| Town/Parish - Burnt Out Vehicle | Town and Parish Councils | Reports of burnt out vehicles reported by town or parish councils. |
| Town/Parish - Complaint to Councillor | Town and Parish Councils | Complaints of anti-social behaviour reported via a councillor. |
| Town/Parish - Dangerous Driving | Town and Parish Councils | Reports of dangerous driving e.g. mini motorbikes reported by town or parish councils. |
| Town/Parish - Drug Related | Town and Parish Councils | Reports of drugs paraphernalia e.g. foils, needles, bong reported by town or parish councils |
| Town/Parish - Fly Tipping | Town and Parish Councils | Reports of fly tipping reported by town or parish councils. |
| Town/Parish - Harassment | Town and Parish Councils | Reports of harassment to town or parish council staff. |
| Town/Parish - Heavy Littering | Town and Parish Councils | Reports of heavy littering recorded by town or parish councils. |
| Town/Parish - Indecency | Town and Parish Councils | Indecent acts, e.g. sexual acts which have not been recorded as a crime, reported by town or parish councils. |
| Town/Parish - Smoke/Fire | Town and Parish Councils | Reports of fires or smoke reported by town or parish councils. |
| Town/Parish - Threat | Town and Parish Councils | Reports of threats to town or parish council staff. |
| Town/Parish - Untaxed Vehicle | Town and Parish Councils | Reports of untaxed vehicles reported by town or parish councils. |
| Town/Parish - Vandalism | Town and Parish Councils | Reports of vandalism by town or parish councils e.g. to park equipment, wooden seats, etc |
| Untaxed Vehicle | BFC - Environmental Health | Untaxed Vehicles notified to the DVLA |
| Vandalism | Thames Valley Police/ Bracknell Forest Homes | Vandalism incidents reported either to the police (but which have not been recorded as a crime) or by Bracknell Forest Homes e.g damage to street furniture, egging, etc. |
| Weapons / Explosives | Thames Valley Police | Reports which have not been recorded as a crime of explosives, e.g. fireworks, or weapons other than firearms, e.g. metal poles, baseball bat, knives, knuckle dusters |
