**GUIDANCE NOTES**

**Dangerous Wild Animals Act 1976**

Applications are made under the relevant legislation and it is a condition of the licence to abide by that legislation. A licence may run either from the date of issue or from 1 January next and remains valid for the remainder of the year in which it is issued.

You must be over the age of 18 to apply for this licence.

You may not apply for a **Dangerous Wild Animals Act** if you have ever been disqualified from any of the following:

- Keeping a pet shop
- Keeping any dangerous wild animal
- Keeping a riding establishment
- Keeping an animal boarding establishment
- Keeping a dog
- Having the custody of animals

Officers authorised by the council will inspect the premises for compliance with the conditions, before granting a licence and without notice when a licence is in force.
