- **Early Years Pupil Premium (EYPP)** is paid to childcare providers where they care for children of families in receipt of certain benefits (e.g. Income Support). It is used to provide extra support for your child such as improving teaching and learning facilities and resources.

The purpose of DAF is to support providers to make reasonable adjustments and build the capacity of their setting to support children with disabilities.

- 1) for children aged from 9 months of eligible working parents: 15 hours per week working parent entitlement funding for 38 weeks of the year (increasing to 30 hours from September 2025).
 - 2) for 2 year olds in families receiving additional forms of support: 15 hours per week Targeted 2 year old funding for 38 weeks of the year. (From September 2025 those 2 year olds also eligible for working parent entitlement: 15 hours per week Targeted 2 year old funding and 15 hours per week working parent entitlement for 38 weeks of the year)
 - 3) for ALL 3 and 4 year olds: 15 hours per week universal funding for 38 weeks of the year. This can be combined with the working parent entitlement for a maximum of 30 hours per week.

In collecting your data for the purposes of checking your eligibility for the Early Years Entitlements, Early Years Pupil Premium (EYPP) or Disability Access Fund (DAF) (see notes 1 – 3), Bracknell Forest Council is exercising the function of a government department. Bracknell Forest Council is authorised to collect this data pursuant to Section 13 of the Childcare Act 2006.

Data Privacy

The Data Protection Act 2018 (the Act) puts in place certain safeguards regarding the use of personal data by organisations, including the Department for Education, local authorities, schools and other early education providers. The Act gives rights to those about whom data is held (known as data subjects), such as pupils, their parents and teachers. This includes:

- The right to know the types of data being held
- Why it is being held; and
- To whom it may be disclosed

Should you have any concerns relating to how your information or the information relating to your child/ren is being or will be used, please contact your provider or Bracknell Forest Council. Please note that information about whether a child is in receipt of Disability Living Allowance is, under the Act, Special Category Data which should be handled appropriately. - **'Targeted' 2 Year Olds** available to 2 year olds in need of additional support (Please only enter data in the top section of table at step 5)
- **Universal 3 & 4 Year Olds** available to all 3- and 4-year-olds (Please only enter data in the top section of table at step 5)
- **Working Parent Entitlement** from 9 months (Please enter data in the bottom section of table at step 5)

To be eligible, children must be accessing the early years entitlements and

- parent/s must be in receipt of certain benefits (e.g. Income Support) OR
- the child must have been in local authority care for 1 day or more in England or Wales, been adopted from care or left care under a special guardianship order or residence order in England or Wales

The information on this form will be used to check eligibility for EYPP.

If you ARE eligible this will NOT impact on any other benefits you receive

If you ARE NOT eligible, this does not affect your funded childcare place

Children who are in receipt of child Disability Living Allowance (DLA) and are receiving Early Years Entitlements are eligible for the DAF, paid to the child's setting as a fixed annual sum.

Note 4: Funded hours

Children eligible for 15 hours funding can access up to 570 hours per year from the term after their qualifying age.

NB 15 hours over 38 weeks is a "term time only" offer. Providers can stretch this offer over more weeks resulting in fewer funded hours each week.

Children eligible for 30 hours funding can access up to 1140 hours per year from the term after their qualifying age.

NB 30 hours over 38 weeks is a "term time only" offer. Providers can stretch this offer over more weeks resulting in fewer funded hours each week.

NB: The maximum number of funded hours a child can receive is:

- 1) for children aged from 9 months of eligible working parents: 570 working parent entitlement hours per year, with a maximum of 15 hours per week (this will increase to 1140 working parent entitlement hours per year from September 2025).
- 2) for 2 year olds in families receiving additional forms of support: 570 hours Targeted 2 year old hours per year, with a maximum of 15 hours per week. From September 2025, for any 2 year olds who are also eligible for the working parent entitlement; a maximum total of 1140 hours (570 targeted + 570 working parent entitlement hours) per year, with a maximum total of 30 hours per week.
- 3) for ALL 3 and 4 year olds: 570 Universal hours a year, with a maximum of 15 hours per week. For any 3 and 4 year olds who are also eligible for the working parent entitlement, a maximum total of 1140 hours (570 universal + 570 working parent entitlement hours) per year, with a maximum total of 30 hours per week.
