**Determination of Application:**

Upon receipt of an application Bracknell Forest Council has **two months** in which to grant or refuse consent. Such consent shall not be unreasonably withheld.

**Failure to apply for consent:**

Under Section 23 (LDA91) if works are executed without first obtaining a formal written consent from us we have the power to serve a notice under Section 24 (LDA91) requiring you to abate the nuisance within a specified time. Should you fail to comply with the notice then we can take the matter to Court. Whether or not you are taken to Court, steps may be taken to abate the nuisance and recover from you the expenses so incurred. Under Section 109 (WRA91) the Agency may remove, alter or pull down any unauthorised work and recover from you the expenses incurred in the process.
