BRACKNELL FOREST COUNCIL COMMUNITY INFRASTRUCTURE LEVY (CIL) MONITORING AND REVIEW REPORT

Report for year 01st April 2017 - 31st March 2018

1 PURPOSE OF REPORT

1.1 The purpose of this report is to set out how much Bracknell Forest Council (the Council) CIL income was received between 01st April 2017 and 31st March 2018, including how the income was spent such as the amount allocated to local Town and Parish Councils in the Borough, etc. The Council as a Charging Authority must report on CIL receipts and expenditure as a legislative requirement set in Regulation 62 of the CIL Regulations 2010 (as amended).

2 BACKGROUND

2.1 In order to secure additional money to create new and improve existing infrastructure to support planned growth in the Borough, such as new schools and transport improvements, the Council CIL Charging Schedule became effective from 6th April 2015 following a decision by the Council at its meeting on 25th February 2015. Therefore, the Council has been charging CIL liability on chargeable new development, such as residential (Use Class C3) and other types of development detailed on the BFC CIL Charging Schedule, which has been granted planning permission or consent from this date. The Council is also able to accept CIL payments in instalments under Regulation 69B of the CIL Regulations 2010 (as amended). The Council also published its CIL Charging Schedule Instalments Policy and Regulation 123 List and this document outlines infrastructure projects or types of infrastructure that shall be funded wholly or partly through collected CIL revenue.

3 REGULATION 62

- 3.1 The Town and Country Planning (Local Planning) (England) Regulations 2012 Part 8 paragraph 34 (5) states, '...Where a local planning authority have prepared a report pursuant to regulation 62 of the Community Infrastructure Levy Regulations 2010(b), the local planning authority's monitoring report must contain the information specified in regulation 62(4) of those Regulations...'. This report must be published for the financial year (01 April to 31 March) and will be available to view on the Council's website (date to be confirmed but shall not be later than 31 December following the end of the financial year (CIL Regulations 2010 (as amended) Part 7 Paragraph 62 (5)).
- 3.2 Regulation 62 (4) of the CIL Regulations 2010 (as amended) requires that the monitoring report includes:
 - the total CIL receipts for the reported year:
 - the total CIL expenditure for the reported year;
 - summary details of CIL expenditure during the reported year including the items of infrastructure to which CIL has been applied, the amount applied to repay money borrowed and the amount and percentage applied to administrative expenses; and
 - the total amount of CIL receipts retained at the end of the reported year.
- 3.3 Between 01st April 2017 and 31st March 2018, BFC issued 38 Liability Notices to the total value of £12,043,940.79. The Liability Notice sets out how much CIL could be payable should the development proceed and no exemptions are applied for and details of the payment procedure. The CIL liability does not become due until a

- demand notice has been issued. Between 01st April 2017 and 31st March 2018 26 Demand Notices were issued with a total value of £11,039,438.93 (including surcharges).
