Purpose

1. This document sets out Bracknell Forest Council's fees and charges in relation to Adult Social Care services.

Principles

2. Bracknell Forest Council will charge for certain Adult Social Care services as identified in this document. Current fees and charges can be found at Appendix A.
3. Fees and charges will be reviewed on a regular basis; the review period for each charge can be found at Appendix A.

Charging for Adult Social Care services

4. The Council will charge for all Adult Social Care services in accordance with the detailed regulations set out in the Care Act Guidance 2014. Full details can be found in the Council's policy document 'Charging Policy for Adult Social Care services'.

Interest on universal deferred payments

5. The Council will charge interest on universal deferred payments in accordance with the rate set by the Department of Health.

Interest on discretionary deferred payments

6. As per 5 above, the Council will charge interest on discretionary universal deferred payments in accordance with the rate set by the Department of Health.

Administration fees for deferred payments

7. The Council will charge an administration fee for setting up a universal or discretionary deferred payment.
8. In addition the Council will charge an annual fee for managing that deferred payment.

Administration fees for self-funders

9. The Council will charge a fee for setting up care arrangements for self-funders i.e. people with capital or assets in excess of the maximum defined by the Department of Health for accessing assistance from Social Services.

10. Additionally the Council will charge an annual fee for the ongoing management of those arrangements.

Arranging alternative support for self-funders

11. The Council will charge a fee for arranging alternative support e.g. in the event of a provider failure. This fee will apply to self-funders or to local authority clients other than those supported by Bracknell Forest Council.

Services for Carers

12. The Council will not charge for services provided to carers.
