## White Ribbon campaign vigil



Thank you to everyone who attended the White Ribbon campaign vigil at The Lexicon, Bracknell on Saturday, 9
December 2023.

The vigil, organised by Bracknell Forest Council, along with local charities

Berkshire Women's Aid and Kaleidoscopic UK, was an opportunity to raise awareness of the White Ribbon Campaign and the 16 days of activism to challenge violence against women and girls. It was also a chance to reflect and remember those that have been lost due to gender-based violence.

It was great to see so many of you show support and help to raise awareness to put a stop to domestic abuse.





## White Ribbon campaign training calendar

Over the 16 days of activism in November/December 2023, 16 domestic abuse related training sessions were delivered with 246 delegates attending from across Berkshire.

Sessions included: Intersectionality and cultural competency; Domestic Abuse and suspected victim suicides; Cost of living: impact on domestic abuse; Domestic Abuse, mental health and alcohol; National Centre for Domestic Violence; Domestic Violence Disclosure Scheme; Stalking Awareness; Honour Based Abuse and Forced Marriage; Domestic Abuse and Older People; Spiritual Abuse; The psychology behind the BRAVE intervention; MARAC & DASH; Child and Adolescent to Parent Violence and Abuse (CAPVA); Coercive Control; Domestic Abuse and post separation abuse; Introduction to the impact of domestic abuse on children.

A big thank you to everyone who offered their time to deliver a session and to all the delegates who attended.

## **Launch of Stay Ok website**

Stay Ok is an easy read website for people with learning disabilities and autism living in the Thames Valley.



We believe it is the first of its kind in the country.







It is designed to provide information and guidance on staying safe whilst at home, and out and about in the community covering a range of topics such as healthy relationships, exploitation and grooming, online safety and hate crime.

Statistics show that people with learning disabilities are more likely to be victims of these crimes yet there is a lack of easy read information available to them. To keep the website interesting there are also quizzes, videos and games all designed to keep people safe. The website is split into two sections, one which is completely easy read and the other is a resources toolkit for parents, carers and professionals.

The website was designed by Buckinghamshire Council in partnership with Talkback. Talkback is a local charity that supports people aged 16 or older with a learning disability and or autism. Focus groups from Talkback were used to test and choose all aspects of the website down to the name and the colour palette. The funding was provided by the Thames Valley Domestic Abuse Coordinators.

#### **December 2023**

<u>Domestic Homicide Oversight Mechanism: HALT study</u> <u>briefings</u>

The Domestic Abuse Commissioner commissioned researchers at the HALT study at Manchester Metropolitan University to conduct analysis of Domestic Homicide Reviews in relation to the following themes: criminal justice, health services, children's services, and adult social care.

#### **HALT Films**

Three <u>films</u> with victim/survivors of domestic abuse and family members who were bereaved due to domestic homicide.

## January 2024

The fourth <u>annual report</u> from the independent Child Safeguarding Practice Review Panel. It looks at the child safeguarding system, based on serious child safeguarding incidents occurring between January 2022 and March 2023. It sets out patterns in practice for national government and local safeguarding partners to better protect vulnerable

children. The report reflects in some depth on six key themes, one of which is domestic abuse and harm to children.

Developed as part of the work by the safeguarding subgroup of the National Asylum Seeker Health Steering Group and cofunded by NHSE South East and Home Office.

## New DHR reports from the Institute of Addressing Strangulation

- The Institute for Addressing Strangulation have published two new reports as part of a series, analysing Domestic Homicide Reviews (DHRs) with regard to themes of strangulation and suffocation.
- The series focuses on Fatal Suffocation (Report 1), Non-Fatal Strangulation (Report 2), and Fatal Strangulation (Report 3), with the potential to add additional perspectives and reports to the series in due course.

## Changes announced to a scheme that supports migrant victims and survivors

- The government has made <u>significant changes</u> to the Destitution Domestic Violence Concession which has been supporting migrant survivors of domestic abuse for over a decade.
- The scheme, newly titled the Migrant Victims
   Domestic Abuse Concession (MVDAC), has been
   expanded to a wider cohort, but this cohort will not
   be able to access a route to settlement after support
   through the MVDAC, leaving a cliff edge in support.
- The Domestic Abuse Commissioner is calling for a comprehensive package of support for migrant victims, which would £2.3 billion in social gains over 10 years.

## 24 February

<u>First refuge for trans and non-binary people opens its doors</u> <u>Loving Me</u>, a service established in 2022 by Trans + people, has now opened referrals for its first refuge.

## 28 February

Women's Aid have launched their <u>2024 Annual Audit</u>, the latest edition of Women's Aid's yearly publication looking at the provision and uptake of domestic abuse services in England, alongside the experiences of women who use them.

Some of the key findings of the report include:

- Almost half of organisations told us they had been running an area of their domestic abuse service in 2022-23 without any dedicated funding.
- The most common type of service running without funding was therapeutic services (43.1%).
- 86.3% of organisations with refuge provision and 81.6% of services with community-based services did not receive any commissioned funding from an ICB.
- When asked about their challenges, organisations most commonly reported short-term contract lengths (33.7%), tenders not recognising quality (32.7%), and complex and unhelpful commissioning processes (32.7%).
- Organisations reported they were struggling to recruit for vacant roles at the salaries they can pay (57.7%), with some losing staff who needed to move to higher paid roles elsewhere (48.1%).
