- Please complete all sections of the form, answering the questions as fully as possible. Do
 not keep back any information as all evidence is of real value in establishing the status of
 a right of way. If you cannot remember any details, please write that you cannot
 remember.
 - When considering a Definitive Map claim we will take into account all relevant evidence available, including completed user evidence forms. If we make an order to modify the Definitive Map, and the order is subject to objections, the evidence will also be examined by an Inspector on behalf of the Secretary of State.
- 3. If completing the form by hand, please use BLOCK CAPITALS for the section about your personal details.
- 4. You will need to complete a separate form for each claim you're submitting evidence for.
- 5. We will only use the information you provide in this form for the purpose of determining the Definitive Map claim. We may be required to share the information for the purpose of processing this application. This means your information may pass into the public domain and therefore cannot be treated as confidential. By signing this form, you are acknowledging that information you provide may be made publicly available. We are committed to protecting your personal data and ensuring that it is processed fairly and lawfully. Information you provide to us will be processed in accordance with the General Data Protection Regulations, The Data Protection Act 2018 and subsequent legislation.
