Notice is hereby given that no representations or objections having been received, Bracknell Forest Council has confirmed the above order without modification. This order took effect on 25 January 2013. The effect of this Order is to modify the Definitive Statement in accordance with section 53(4)(a) of the 1981 Act.

The wording of the definitive statement shall be modified as provided below:

- i) Binfield Bridleway 24: To improve accuracy of description. Amend the wording From: Bottle Lane E of Hazelwood Farm, SW to read 'Bottle Lane, opposite Bridleway 19'. Amend the wording To: Cabbagehill Farm Road to read 'The junction with Cabbagehill Lane'.
- ii) Bracknell footpath 5: Amend the wording From: S side of the road N of "Doncastle House", S along Longshot Lane to read 'W side of Doncastle Road with the junction of the A329M'.
- iii) Crowthorne bridleway 14: To improve accuracy of description. Amend the wording To: FP8 at Butter Hill to read 'To join the Devil's Highway (Crowthorne RB12), 180m W of its junction with Crowthorne FP8'.
- iv) Sandhurst footpath 21: Noting change in road names following construction of A3095 Rackstraw Road. Amend the wording From: Junction of South Road and Owlsmoor Road, ESE to read 'From barrier on South Road, 350m N of its junction with Rackstraw Road, E along the parish boundary'.
- v) Warfield byway 13: Noting change in description due to construction of Harvest Ride. Amend the wording From: Lackman's Hill, S to read 'Watersplash Lane, E of its junction with The Splash, S across Harvest Ride'.
