## **Risk Assessment Scoring**

**Consequences** – most probable result of the potential accident

<u>Consequences</u>	<u>Score</u>
Death	100
Permanent disability (including amputation or impairment of any function)	50
Temporary disability for more than 3 weeks	25
For 3 days to 3 weeks	5
For less than 3 days	3
Minor Ailments (cuts, bruises, bumps and no lost time)	1

**Exposure** – the frequency of occurrence of the hazard event

<u>Exposure</u>	<u>Score</u>
Hazard present: many times daily	10
Once a day	6
Once a week to once a month	3
Once a month to once a year	2
Less often than once a year	1

**Probability** – likelihood of accident sequence following to completion

<u>Probability</u>	<u>Score</u>
Very likely	10
Likely to occur	6
Possible	3
Very Unlikely	0.5

A multiplication of these three values will give an overall risk score. This will enable a judgement to be made as to action required
