

## Application for payment of Local Housing Allowance to your landlord

Under the Local Housing Allowance (LHA) scheme, we will usually pay benefit to you, the tenant. You must then pay the rent to your landlord yourself.

However if you have difficulty managing your financial affairs we may be able to make payments directly to your landlord.

If you would like us to consider making payments to your landlord, please complete this form and return it to us, together with the proof we need.

This form should be filled in by you, the tenant. However, if you have difficulty, it can also be filled in on your behalf by, for example:

- family or friends
- social worker or care worker
- advice or welfare agency
- your landlord
- a Housing Department

We will send you our decision as soon as we can. If we need further information from you we may write to you or interview you and/or your representative.

If you or your landlord disagrees with the decision you can appeal against the decision.

I am unable to open a bank account or am an undischarged bankrupt

Letter from bank, Citizens Advice Bureau or, in the case of bankruptcy, a copy of the Court Order.

I have a history of rent arrears or Homelessness

Proof from support groups, homeless charities, local authority housing department.

# LANDLORD DIRECT PAYMENT FORM

## LANDLORD'S UNDERTAKING

(This section must be signed by the landlord before any rent direct payment(s) can be made)

### Declaration

1. I am the landlord of the above named tenant.
2. I, as the landlord of the above, understand that it is a criminal offence to dishonestly or without reasonable excuse, fail to notify the Benefit Section of any change in circumstance that I am required by the Housing Benefit Regulations to report. These include a change in my tenant's (or a member of the tenant's household) :
  - rent or terms of the tenancy,
  - if they move property, or to a different room within the property,
  - income,
  - if they start or stop work,
  - if they are or will be, absent from the property for a period of time,
  - if someone joins or leaves the household,
  - any other change that may affect entitlement to benefit.
3. I am prepared to accept Housing Benefit payment on behalf of the tenant.
4. In accepting payment I am aware that if any overpayment of Housing Benefit should occur, I am liable to reimburse the Council for the full amount of any such overpayment. This includes any overpayment that may occur when the Council makes an interim payment of benefit whilst awaiting further information concerning the benefit claim.
