## **e+ PASS Verifier Form A**

If you want to apply for an e+ PASS proof of age card but **do not have photographic proof** to show (e.g. passport, photo driving licence) you can ask a verifier from the list below to confirm that the details supplied on the form match your details held on their official records.

### **Any of the following can act as your verifier to authenticate the details on this form:**

- *Careers/Connexions Adviser – checking against Education Authority records*
- *Teacher/Tutor/Head of Year/Administrator - checking against Education Authority records*
- *Doctor/dentist/nurse/administrator – checking against NHS records*
- *Social worker – checking against Local Authority social services records (social work records in Scotland)*
- *Prison or probation officer –checking against prison/probation records*
- *Bank/Building Society Staff – checking against FSA compliant records*
- *Certified Solicitor/Accountant – checking against FSA compliant records*
- *Job Centre/DWP advisors – checking against DWP records*
- *Local authority staff –checking against Local Authority personnel records*

You need to fill the first section overleaf yourself and take it to your verifier with a clear, recent photo of yourself. (You could ask council staff for a colour printout of the e+ photo taken at registration for this rather than paying to have a photo printed)

### **Then, your verifier will need to complete all of the following:**

- confirm your full name, home address & date of birth
- endorse (write that it is an accurate likeness of you), sign and date your photo,
- fill in the second section of the form below and
- mark it with an **official stamp** from their place of work.
- sign the verifier's declaration at the bottom

Once it has been received, a council officer will contact the verifier at their place of work to confirm that they did countersign the form.

### **The photo submitted with this form must:**

- have the words 'this is an accurate likeness of (applicant's name)' on the reverse and be signed and dated on the back by the verifier
- be a recent, colour, focused image
- be a clearly recognisable full face head and shoulders image of the applicant
- show the applicant without headgear or dark glasses (except for medical or religious reasons)
- have no hair covering the eyes

The completed form with the verifier's official workplace stamp along with the signed, endorsed photograph may be taken back to a Bracknell Forest library, e+ leisure site or customer service centre or posted to:
